

## RAPTER Industry Day

### Frequently Asked Questions

1. **What will participants gain from attending RAPTER Industry Day?** This event will provide an opportunity for industry partners to gain insight into TSMO's mission, requirements, and objectives. Participants will learn about:
  - Current threat capabilities
  - Technology limitations and gaps
  - Planned developmental activities
  - Objective threat force capabilities
2. **What is the goal of RAPTER Industry Day?** TSMO's goal is to engage with industry partners to explore innovative solutions for the rapid prototyping and development of affordable threat systems. Areas of interest include:
  - Threat electronic attack (EA) and electronic support (ES) systems
  - Multi-band radar solutions
  - RF emitters
  - Communication systems
  - Network solutions
3. **What is the overall intent of RAPTER Industry Day?** This event is intended to inform and support potential future solicitation(s) for distributed and expeditionary next-generation threat simulator solutions, systems, and complex electronic warfare (EW) and electromagnetic spectrum (EMS) environments.
4. **When and where will the event be held?** The event will be held on **November 19<sup>th</sup>, 2025**, at **Redstone Arsenal, Alabama**. The exact location will be provided in the event invitation.
5. **Will an agenda be provided for RAPTER Industry Day?** Yes. An agenda will be provided approximately **10 days** prior to the actual date of Industry Day.
6. **Is there a cost to attend RAPTER Industry Day?** No. This is a free event. All costs associated with participating are at the industry partner/company's expense.
7. **Is RAPTER Industry Day intended for market research, and will a formal Request for Information (RFI) be provided?** RAPTER Industry Day is a part of TSMO's market research plan to support potential future solicitations. A RFI will be provided **within 30 days after the event**, via email, to industry partners who attend the industry day.
8. **What is the classification level of discussion, demo, and briefings during RAPTER Industry Day?** All discussions, demonstrations, and briefings will be **UNCLASSIFIED**.
9. **Why is there a limit to 2 people per interested company/firm that may attend RAPTER Industry Day?** Due to limited space and capacity, we are restricting attendance to a maximum of two (2) people per company.

**10. What are the next steps after requesting attendance?** After requesting attendance, the next steps are as follows:

- Verification of Security Classification/Information by TSMO Security Office.
- Once verification is complete, you will be notified and provided with [Base Access Instructions for Redstone Arsenal](#).
- An email invitation containing RAPTER Industry Day location, agenda, and other pertinent details will be provided within **10** days of the actual event.

**11. Is our (interested companies/firms) security office required to contact you?** No. Your security office does not have to contact TSMO.

**12. Can interested companies/firms demo their products or systems during RAPTER Industry Day?** No. RAPTER Industry Day is for the Government to provide insight into TSMO's mission, requirements, and objectives.

**13. Will there be a display of threat simulators to help interested companies/firms better explore innovative solutions for rapid prototyping and development?** Yes. There will be an opportunity to view simulators and ask questions.

**14. Will virtual access be available for this Industry Day?** No. This is an in-person event. All attendees must be verified by TSMO Security Office.

**15. Is there a minimum FCL and/or safeguarding level required to attend RAPTER Industry Day?** Yes. The minimum level required is **SECRET**.
